I. INTRODUCTION

This demo file is intended to serve as a “starter file” for the SSBA Symposium 2018.

These guidelines include complete descriptions of the fonts, spacing, and related information for producing your manuscripts. Please follow them and if you have any questions, direct them to the Chair: Nataša Sladoje, email: nataša.sladoje@it.uu.se.

All manuscripts must be in English. You need to provide a camera-ready PDF file with 4 pages, A4 size. We will need to edit them to add headers and page numbers. This means that:

- Do not add page numbers, headers nor footers.
- Do not change margins.

For consistency within the proceedings, please do not change column spacing, font shapes, font sizes, etc.

II. TYPE STYLE AND FONTS

The whole document should be typeset in Times Roman or Times New Roman. If neither is available on your system, please use the font closest in appearance to Times. For example, many Linux distributions have a font called Liberation Serif, which is metric-compatible with Times New Roman. Do not use bit-mapped fonts. True-Type 1 or Open Type fonts are preferred. Please embed all fonts into the PDF file.

The main text needs to be set in 10pt font. The abstract uses 9pt bold font. Abstract and main text is typeset in two columns, 82mm in width. Leave 6mm between the columns. The left and right margins are 20mm wide; top and bottom margins are Xmm and Ymm respectively.

The last page should have the two columns of approximately equal length. You might need to balance the columns manually.

A. Title, authors and affiliations

The title is set in 24pt font, and is centered on the page, in a single column. The author list is typeset in the same font shape and size as the main text. Names are separated by commas, the last name with ‘and’. Below the list write

Fig. 1. Figure captions are typeset like so. A one-line caption should be centered, a multi-line caption must be justified. Try to place figures at the top of the columns, except in the first column.

the affiliation, address and email addresses. If there is more than one affiliation, give each author name one or more footnote marks, and list the various affiliations and addresses preceded by the corresponding footnote mark. Do not use a footnote mark if there is only one affiliation. Author list and affiliations are centered on the page below the title.

B. Sectioning

Section headings are in 10pt small caps, and numbered using roman numerals.

Subsection headings are typeset in italics, and numbered using capital letters.

1) *Subsubsections*: Subsubsections are numbered using arabic numerals, and the headings are run-in with the text.

III. FIGURES AND TABLES

Figures should be placed preferably at the top of columns, and never within text. The first column should not have any figures.

Figure captions should be set in 8pt font, and start with “Fig.” and the figure number in arabic numerals, followed by a period. To reference a figure, use the same format: Fig. 1 is our demo figure.

Tables are formatted differently from figures. The caption should be at the top, and uses 8pt small caps. Tables are numbered using roman numerals. The label “TABLE I” will be on a line of its own, followed by a short table caption. The table can be referenced as Table I.

It is fine to make a figure or table that spans the two columns.

IV. REFERENCES

Citations should be referenced in the text with numbers between square brackets [1], multiple references look like this [2], [3], [4], [5]. A references section at the end of the document lists the references, in the order in

which they first appear in the text. That is, reference 2 cannot be referenced before reference 1. Please format the references as demonstrated at the end of this document, using 8pt fonts. We follow the citation style of the IEEE.
